


FIRST QUARTER UPDATE: POST HIMSS, CHATGPT, INTEROPERABILITY

As we enter the second quarter of the year, we wanted to share some of the latest news and developments in the healthcare industry with a particular emphasis on post HIMSS conference and focus on generative AI.

The HIMSS conference held in Chicago IL brought together nearly 40,000 (light compared to the pre Covid19 levels of 45k) leaders in healthcare technology to share insights and new ideas that are transforming the industry. One area that received significant attention was ChatGPT and generative AI, technology that is poised to revolutionize healthcare in the coming years. Generative AI algorithms have the ability to learn from vast amounts of data and generate new insights and predictions based on that information. This can lead to more accurate diagnoses, more effective treatments, and better patient outcomes.

Several major players in the healthcare industry have already made significant investments in generative Al technology. For example, Amazon Web Services (AWS) recently launched Amazon HealthLake, a service that uses generative Al algorithms to help healthcare providers store, transform, and analyze patient data securely in the cloud. Meanwhile, Microsoft has partnered with healthcare providers to develop Al-powered tools that can predict patient outcomes and enable early intervention. Recently announcing a partnership with EPIC to integrate Azure OpenAl into EHRs.
