


SECOND QUARTER UPDATE: MARKET REBOUND AS AI IS EVERYWHERE

Despite the market concerns, the rebound of stocks, including the LECO Index since lows of late 2022, have surprised most everyone as venture investments have dried up while M&A is at near 10 year lows.

While data, specifically medical data, is considered the new gold, unfortunately, the rise in investor's acknowledgement of this does not correlate with their willingness to deploy capital in the first half of 2023 See Chart RCM, Healthcare IT Deal Flow Chart below – the large spike in Q22022 was **Oracle (NYSE: ORCL)** \$28B acquisition of **Cerner (NASD: CERN)**. The challenging market of 2022 saw decades-high inflation rate and rising interest rates, the Russian-Ukraine war that sparked supply chain and energy crises, and the possibilities of a recession have fueled economic uncertainty that led to the plummet in deal volume. Even though a global financial crisis was narrowly avoided with timely government interventions, investors entering Q2 2023 anticipated a recession due to the downfall


of prominent banks like Silicon Valley Bank, and First Republic Bank along with historical takeover of Credit Suisse by UBS.


Nevertheless, in Q2 2023, the pool of reserved capital has witnessed greater confidence in allocation, a product of the stabilizing economy with less stubborn inflation and the surge of artificial intelligence "Al" that drove the S&P up 17% in first half of 2023. Likewise, the revenue cycle management (RCM) and Healthcare IT markets also dipped in deal volume late 2022 – early 2023, and signs of revival are more evident than ever with potential Al integration in the healthcare system using medical data.



If you have not heard about generative AI or Gen AI, then you are either too busy coding or billing and need to give it a try with technology like Open AI. Generative AI is a type of artificial intelligence technology that can produce various types of content, including text, imagery, audio and synthetic data. Significant amounts of investments by both large and small companies are expecting substantial ROI thru efficiencies of processes while creating better more personalized services.

Al-powered Platforms Transforming Patient Care and Workflow Management

The continued advancement of artificial intelligence (AI) capabilities, coupled with its increased accessibility to the public, has fostered the development of new platforms integrating natural language processing, machine learning, and deep learning. Notably, the following businesses have been successful in garnering substantial investments in this field:

- Virtual Health Assistance: Natural language processing's development has made it possible to provide mass-market individualized health assistance. To improve each patient's experience with their provider, these virtual health assistants provide features including reminders, health diagnoses, and individualized planning. Companies like Access Telehealth (Healthcare Technology Systems) and Electronic Caregiver are operating in this segment.
- 2. **Remote diagnosis**: By utilizing AI and its deep learning capabilities to analyze data streams collected from electronic devices embedded with various sensors, such as smartwatches, companies are now able to identify the risk for a person developing a specific disease in advance. Companies like **ClinOne**, **Korion health**, **Trapollo** are operating in this segment.
- 3. **Healthcare Flow Planner**: Al technologies are becoming essential for continuously monitoring a person's vital indicators and giving them feedback in real time. This allows individuals to identify the need to seek medical care more quickly and can even be a preventative measure that warns its users of looming health risks. Companies like **Strive Health**, **Prognos Health**, **RxLightning Inc.** are operating in this segment.
- 4. Clinic Workflow Management: By automating a variety of operations linked to patient care, administrative responsibilities, insurance procedures, and cost management, artificial intelligence is transforming how doctors, other healthcare professionals, and even entire hospital systems function. Companies like Cyclica, Arcadia Solutions, and DexCare are operating in this segment.

Advances in the healthcare sector mark a substantial move toward intelligent, data-driven healthcare solutions. Utilizing AI, machine learning, and deep learning algorithms more frequently has the potential to significantly enhance patient outcomes, optimize resource allocation, and support better healthcare decisions. Furthermore, interest has been building from investors and companies operating in the HealthTech domain and as a result, the AI craze will likely continue for years to come.

Generative AI is at the forefront of the HCIT space and is being used to **simplify and automate the overly complicated healthcare revenue cycle** that has been the bane of smaller practices and hospital systems alike for years. Here are some items to note when evaluating the potential for utilizing generative AI to automate the revenue cycle

- 1. Gen Al uses in RCM: Al will be able to streamline the process of the generation of prior authorization submissions and denial appeals; look at historical data around scheduling, registration, charge capture, billing, and collections to reduce cost to collect, improve work processes, and even predict denials; and accelerate the implementation of existing rules-based automation products such as taking in payer contracts and creating templates for coding and submission. All this ultimately speeds up payment cycles, improves coding quality and efficiency, and reduces costs.
- 2. **Risk to consider:** The quantity of practices and hospitals with less financial flexibility, data silos, and archaic technological infrastructure should be taken into account when investing in Al-powered RCM solutions. Investors should be cautious when evaluating a company in this space and ensure that the RCM solution can feasibly be implemented on a broader scale given current technology.
- 3. **Differentiating factors:** Capable of doing the work of experienced coders for more complex claims, predictive analytics capabilities to identify most collectible claims, end-to-end functionality.

PUBLICLY TRADED RCM & HCIT COMPANIES

Our LECO RCM & HCIT Index makes a great start after a tough year (2022) with a bounce of 16.36% for the quarter and -23.59% for the full fiscal year. The performance of our index has been consistent with the 16% growth of the NASDAQ Composite this quarter, although NASDAQ has performed significantly better this fiscal year achieving 35% growth. Dow Jones has exhibited 3.2% and 3.8% increases over this quarter and the fiscal year respectively, while the S&P grew by 8.3% and 13.2% over this quarter and the fiscal year respectively.

The most notable transaction in the quarter occurred on June 6th, 2023, with **General Electric (NYS: GE)** selling its 6.4% stake in **General Healthcare Technologies (NAS: GEHC)**, which took place five months after GEHC's spinout. GE offloaded 25 million common stocks for \$78.00 per share that amounts to \$1.9 billion in total value. GEHC eventually recorded a slight quarterly drop of 1.1%, finishing at \$81.24. Conversely, some companies in our index witnessed sizable quarterly growth. Thriving from the tailwind of the Artificial Intelligence "AI" frenzy, **Oracle (NYS: ORCL)** saw new all-time highs with a 31.58% surge in share price from the previous quarter and a 70.45% TTM gain, while Multiplan (NYS: MPLN) recovered with a 99.06% quarterly gain, cutting its TTM loss to under 62%. **R1 RCM (NAS: RCM)** broke even in Q1 and subsequently recorded a 23.14% quarterly gain. **McKesson Corporation (NYS: MCK)** also notched an impressive 19.43% quarterly gain and 30.99% TTM gain.

Coming into Q2, investors saw the fresh collapse of Silicon Valley Bank and stubborn inflation despite the Federal Reserve's multiple rate hikes that greatly fueled market uncertainty, thus the M&A market remained largely inactive. However, the economic rebound near quarter-end, combined with the dry powder awaiting deployment since mid-2022, signals the much-anticipated comeback of the U.S. economy that promises a more active Q3 for our index's companies.
