

Key Highlights



- Medical aesthetics is a field within medicine that focuses on improving a person's appearance, enhancing their sense of well-being or to cure certain medical conditions.
- It encompass a diverse range of applications, including anti-aging, skin rejuvenation, breast enhancement, body shaping, tattoo removal, vascular lesion treatment, and management of skin conditions like psoriasis and vitiligo.
- The industry is booming thanks to innovative skin treatments that cater to all skin types, with a focus on non-invasive or minimally invasive procedures like facelifts, botox, liposuction, and laser hair removal, catering to a wide age range.
- In 2022, the revenue generated by the US medical devices sector amounted to approximately \$9B this figure expected to surge to approximately \$14B by 2027, reflecting a CAGR of 9%. Concurrently, consumer spending is poised to exhibit parallel growth, climbing from \$26B in 2022 to an anticipated \$40B by 2027.
- The growth in this trend is driven by a growing desire for improved physical well-being, rising female labor force participation, and advancements in technology.
- As per the International Society of Aesthetic Plastic Surgery (ISAPS) survey, the
 United States retained its position as the top nation in globe for plastic surgery
 procedures, recording a total of approximately 7.4 million performed,
 comprising 1.6 million surgical procedures and 5.8 million non-surgical
 treatments.

Trends in Medical Aesthetics





Focus on Healthy Regenerative Ageing

Regenerative aesthetics is a rapidly evolving field that aims to restore aging skin and recapture youthful tissue structure and function. Consumers and new age startup increasingly seek bio-stimulation treatments for long-term cell regeneration and tissue health, prioritizing lasting benefits over quick fixes.



Social Media Influence and Increased Awareness Among The Masses

With people spending an average of 2 hours and 27 minutes daily on social media, the promotion of idealized body standards and self-awareness is amplifying interest in medical procedures, thereby boosting participation in the medical aesthetic market.



Minimally Invasive Aesthetics on the Rise

Minimally invasive medical aesthetics treatments are gaining popularity due to their lower risks, quicker recovery, and outpatient options, leading to a projected 9.03% CAGR growth in the non-invasive aesthetic treatment market, reaching \$19.94 billion by 2028.



Advancement in Technology

Advanced technology and devices are transforming patient procedures and assessments in medical aesthetics. Companies like Allergan, Alma Lasers, Cutera, and others are heavily investing in RF, laser, ultrasound, plasma tech, and AI for data assessment, patient diagnoses and treatment.

Aesthetics Procedures in U.S.



- There has been a significant surge in the number of aesthetic procedures performed in the United States over the past few years, nearly doubling to 7.45 million in 2022 compared to 2018.
- The data indicates a growing preference among individuals for non-surgical procedures, as its share has been increased from 66% to 77% in five year of the total procedure performed in a year.
- This shift can be attributed to several factors, including the convenience of non-surgical treatments, their increased adoption by clinics and medspas, and that they generally involve fewer, if any, long-term adverse consequences when compared to surgical procedures.





2022 Surgical Procedures in USA







Growing Segments





In the coming years, the Facial Aesthetic segment will witness significant expansion, with a focus on non-surgical and minimally invasive treatments and products designed to enhance facial beauty.

This growth is being propelled by

- Increasing number of working women
- Higher disposable incomes
- Strong desire for a more youthful appearance.

As per AAFPRS's 2020 survey, the COVID-19 pandemic triggered a notable surge in demand for facial plastic surgery. This surge was primarily fueled by what they have coined as the "ZOOM effect," wherein individuals became got hyper-aware of one's own on-screen image



Botulinum toxin injections are widely used in cosmetics to block nerve signals to targeted muscles, preventing muscle contractions and promoting a youthful appearance.

Botulinum segment will witness an exponential growth because of

- Growing research and development in the space
- Patient preference for noninvasive or minimal treatments

As per the ISAPS, Botulinum Toxin has the largest share among the number of total non-surgical procedure performed in the year 2022 in U.S., witnessing a growth of 56% from the year 2021. Global Botulinum Toxin market is expected to grow by CAGR of 8.4% over next 10 years



The clinics, hospitals, and medical spas sector currently dominates the market and is poised to maintain its leading position in the years to come. This segment is expected to experience the highest CAGR.

The growth in this segment can be attributed to

- The increased availability of both infrastructure and financial resources
- Rising number of surgeons offering aesthetic services.

According to AmSpa's report, medical spas have surged from 7,430 to 8,841 in the year 2022, a 19% Y-o-Y increase. The 2022 ISAPS survey shows that the United States has the world's highest number of plastic surgeons, totaling 7,431, marking a 6% rise since 2018, mostly practicing in the Hospital and clinics.


- The medical spa industry has experienced remarkable growth in both revenue and the number of clinics over the past few decades.
